1. SUMMARY AND BACKGROUND

Coastal KZN TVET College is a Public TVET College with eight Campuses, four Skills Centres, and a Central Administration Office. Coastal KZN TVET College catchment area is South of Durban and continues for a strip of about 80km towards the South Coast. It includes Ozwathini, Hammarsdale, Durban, the Bluff area, Chatsworth, Lamontville, Umlazi, KwaMakhutha, Prospecton, Amanzimtoti, Illovo right down to Scottburgh and Umzinto.

COASTAL KZN TVET COLLEGE invites suitably qualified and experienced service providers to submit bids for the leasing of thirteen (13) vehicles for a period of thirty-six (36) months. The successful bidder will be required to provide fully maintained, insured, and roadworthy vehicles as specified in this document.

2. REGISTRATION ON CENTRAL SUPPLIER DATABASE

The bidder must be registered on Central Supplier Database (CSD) to do business with the College. A copy of CSD Report must be submitted with the bid and failure to submit will result in disqualification.

3. COMPULSORY DOCUMENTS/ COMPULSORY CONDITIONS OF THE CONTRACT

The bid must be submitted in a sealed envelope with the name of the company, item description and bid number clearly marked on the envelope. The following documents **must** be submitted with the proposal.

- Company profile showing that the bidder already provide vehicle leasing services.
- At least three (3) previous contracts for vehicle leasing or fleet management. (lease agreements, Service level agreements or Memorandum of Understanding (MOUs)
- Proof of fleet ownership or access to vehicles (e.g., lease agreements, manufacturer partnerships). At least 13 vehicles
- B-BBEE Certificate or Sworn Affidavit.
- Valid Tax Clearance Certificate and
- CSD Report that is not more than three (3) months old
- Public Liability Insurance for at least R1 000 000.00
- Bank Rating Letter with ratings A/B/C

3.2 Stage 2 - Functionality / Technical

The functional/technical evaluation will be based on a threshold, where Bidders who fail to achieve a minimum of 70 points out of a total of 100 points will not be considered further in the evaluation process. It should be further noted that bidders who score less than 70% in each sub-category for Functionality / technical will not be considered.

The criteria will be as follows:

SECTION 6

6.1 GENERAL CONDITIONS

- The contract shall be for a fixed period of 36 months from the date of commencement.
- Escalation of rates will be in according to the inflation rate of the financial year.
- The College reserves the right to terminate the contract within 30 days' notice in the event of non-performance.
- The lessor must provide monthly fleet reports, including vehicle condition and mileage.
- Vehicles must be delivered to the College within 30 days of award.
- Delivery will be inspected for compliance with specifications before acceptance.
- The College reserves the right not to accept the lowest or any bid.
- Late, faxed, or emailed bids will not be accepted.
- All bids must be submitted in a sealed envelope marked with the bid number and description.
- The successful bidder may not sublease or subcontract without written approval of the College.
- Ownership of all vehicles remains with the lessor; the lessee shall not incur any liability.

6.2 SCOPE OF WORK

The successful service provider will be required to lease and maintain the following vehicles for Coastal KZN TVET College:

6.3 VEHICLE SPECIFICATIONS AND REQUIREMENTS

All leased vehicles must meet the following minimum requirements:

Condition:

Vehicles must be brand new

Odometer reading must not exceed 1,000 km at handover.

Registration & Licensing:

Fully registered and licensed in the name of the lessor, with copies provided to the College.

License renewals must be done by the lessor at their cost for the duration of the contract.

Insurance:

Comprehensive insurance must be provided by the lessor.

Insurance must cover theft, fire, accidents, natural disasters and third-party liability.

Maintenance & Repairs:

All servicing and repairs (mechanical, electrical, and bodywork) to be carried out at the lessor's cost.

Vehicles must be serviced according to manufacturer specifications.

The lessor shall provide a service schedule for each vehicle.

Replacement Vehicles:

When any vehicle is taken for service or repair, a replacement vehicle of similar class must be provided within 24 hours to ensure continuity of College operations.

Breakdowns and Emergencies:

24-hour roadside assistance must be available.

Contact numbers for emergencies must be provided.

Branding:

Vehicles must be branded with the Coastal KZN TVET College logo.

Fuel:

The College will be responsible for fuel costs unless otherwise specified.

Tracking System:

All vehicles must be fitted with a GPS tracking device with live monitoring capability for lessee's vehicle management

College Vehicle Replacement Cycle

Should any vehicle become uneconomical to repair or remain unserviceable for more than 5 working days, the lessor must replace it with an equivalent vehicle at no additional costs.
